

What is this product?	
Туре	The Fund is an approved sub-fund of the Company which is authorised as a UCITS by the Central Bank of Ireland.
Term	This Fund is an umbrella type open-ended UCITS and this product is not subject to any fixed term. CG Asset Management Limited may not terminate the Fund unilaterally. Further information on the termination provisions relating to the Fund is available in the Company's Prospectus and constitutional documents.
Objectives	The investment objective of the Fund is to achieve long term capital growth in absolute terms. The Fund is actively managed and is not actively managed in reference to a benchmark.
	The Fund will attempt to achieve its investment objectives by investing in a spread of direct equities, exchange traded Funds, open ended Funds, closed ended Funds, government and corporate bonds including Index- Linked Bonds, all listed on a Recognised Market. Through investing in investment trusts and investment companies, the Fund will obtain exposure to global and domestic equity markets, real estate, infrastructure, commodities and precious metals.
	The Fund will also use warrants, convertible loan stocks and convertible bonds to gain exposure to these assets. The Investment Manager will limit the use of derivative instruments to convertible bonds and warrants.
	The Fund may cross-invest in other sub-funds of CG Portfolio Fund plc.
Intended Investor	The Fund is suitable for investors seeking capital appreciation with a medium to long term investment horizon and who are prepared to accept a moderate level of volatility. The Fund may not be suitable for any investor who requires their money within three years.

What are the risks and what could you get in return?



The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a mediumlow risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

How long should I hold it and can I take my money out early?

Recommended holding period: 5 years

The fund has daily liquidity. The recommended holding period of the fund is 5 years and it assumes the fund being the sole or majority holding of the investor. The recommended holding period is primarily based on the historic volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.
