### What is this product?

<b>Type</b>	The Fund is an approved sub-fund of the Company which is authorised as a UCITS by the Central Bank of Ireland.
<b>Objectives</b>	<p>The investment objective of the Fund is to achieve long term capital growth in absolute terms. The Fund is actively managed and is not actively managed in reference to a benchmark.</p> <p>Overall asset allocation between closed ended investment trusts and investment companies, government bonds, corporate bonds (both fixed and floating rate) and cash reflects an assessment of long term value, risk and liquidity. The asset allocation of the Fund is expected to be approximately 30% in ordinary shares of investment trusts and investment companies whose underlying exposure would be global and UK equity markets, real estate, infrastructure, commodities and precious metals.</p> <p>The Fund will also use exchange traded Funds, warrants and convertible loan stocks and bonds to gain exposure to these assets.</p> <p>The Investment Manager will limit the use of derivative instruments to convertible bonds and warrants.</p>
<b>Intended Investor</b>	The Fund is suitable for investors seeking capital appreciation with a medium to long term investment horizon and who are prepared to accept a moderate level of volatility. The Fund may not be suitable for any investor who requires their money within three years.
<b>Term</b>	This Fund is an umbrella type open-ended UCITS and this product is not subject to any fixed term. CG Asset Management Limited may not terminate the Fund unilaterally. Further information on the termination provisions relating to the Fund is available in the Company's Prospectus and constitutional documents.

### What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level and poor market conditions are unlikely to impact the capacity for you to receive a positive return on your investment.

## How long should I hold it and can I take my money out early?

**Recommended holding period: 5 years**

The fund has daily liquidity. The recommended holding period of the fund is 5 years and it assumes the fund being the sole or majority holding of the investor. The recommended holding period is primarily based on the historic volatility of the underlying investments and is not directly applicable if used in a portfolio based on the investor's risk profile. The fund is not intended for short term speculation purposes.
